\*The shares of common stock (the "Shares") of Stellar Acquisition III Inc., a Republic of Marshall Islands Corporation (the "Issuer"), reported herein are held by Boothbay Absolute Return Strategies LP, a Delaware limited partnership (the "Fund"), which is managed by Boothbay Fund Management, LLC, a Delaware limited liability company (the "Adviser"). The Adviser, in its capacity as the investment manager of the Fund, has the power to vote and the power to direct the disposition of all Shares held by the Fund. Accordingly, for the purposes of Reg. Section 240.13d-3, the Adviser may be deemed to beneficially own an aggregate of 848,631 Shares, or 9.42% of the Shares issued and outstanding as of October 9, 2017. Ari Glass is the Managing Member of the Adviser. The beneficial ownership percentage reported herein is based on 9,010,177 voting Shares issued and outstanding as of October 9, 2017, as disclosed in the Issuer's Quarterly Report for the quarter ended August 31, 2017, as filed with the Securities and Exchange Commission on October 10, 2017.
