As per the 10-Q filing on 10/11/17, there were 9,010,177 shares of common stock outstanding as of 10/09/17. The percentages set forth herein were derived using such number. Phillip Goldstein, Andrew Dakos and Steven Samuels own Bulldog Investors, LLC, a registered investment adviser. As of February 8, 2017, Bulldog Investors, LLC is deemed to be the beneficial owner of 686,558 shares of STLR by virtue of Bulldog Investors, LLC's power to direct the vote of, and dispose of, these shares. These 686,558 shares of STLRU include 316,789 shares (representing 3.52% of STLR's outstanding shares) that are beneficially owned by the following entities over which Messrs. Goldstein, Dakos and Samuels exercise control: Opportunity Partners LP, Calapasas West Partners LP, Full Value Special Situations Fund LP, Full Value Partners LP, Opportunity Income Plus Fund LP, and MCM Opportunity Partners LP (collectively, Bulldog Investors Funds). Bulldog Investors Funds may be deemed to constitute a group. All other shares included in the aforementioned 686,558 shares of STLR owned by Bulldog Investors, LLC (solely by virtue of its power to sell or direct the vote of these shares) are also beneficially owned by clients of Bulldog Investors, LLC who are not members of any group. The total number of these "non-group" shares is 369,769 shares (representing 4.10% of STLR's outstanding shares).
